  "TRUSTEES" (Which expression shall unless excluded by or repugnant to the subject or context mean the Trustees for the time being of the Trust of OTHER PART;

## WHEREAS:-

- 2. The objects and purposes of the Trust are as follows:-
  - To impart, promote and spread education in General Children Class Nursary to Class Xth made the syllabus of C.B.S.E. New Delhi.

    - (e) To provide libraries, reading rooms for the benefits of the students and general public for promoting the said education. The Trust is known as Holy Educational Trust with power to the Trustees to change the name of the Trust if the Trustees so decide.

The office of the Trust is situated in Moh.-Mandraj

Bigha, Chhotki Delha, Gaya.

- The member of the Trustees shall not be less than five and not more nine. The Trustees shall be Trustees for their life time but any Trustee may resign by giving notice in writing to his co-Trustees and shall also cease to be a Trustee if requested in writing by at least Three fourths of the remaining Trustees or the number nearest thereto. Appointment of Trustee either to fill up a vacancy or as additional Trustee (s) shall be by unanimous resolution of the Trustees for the time being.
- 6. The management and cotrol of the Trust for the purposes of managing the Trust affairs and properties, and carrying out the objects of the Trust aforesaid, shall be vested in the "BOARD OF TRUSTEES" headed by Settlor/author of the Trust till his life as the chief Trustee of the Trust and consisting of all the Trustees named above i.e. the existing Trustees for the time being. The Trustees with not be entitled to receive any remuneration as trustee but may reimburses themselves of all expenses actually incurred by may get honorarium for wholetime rendered by them in connection with Trust or their duties relating thereto.

7. The profits, income and property of the Trust will be applied solely for the promotion of the objects of the Trust, as set forth above and no portion thereof shall

- 8. The Board shall without prejudice to the generality of the objects and powers above named have power to do all or any of the following things that is to say:
  - (a) To enter into contract and borrow money for the purposes of the Trust and management of its properties and assets.
  - (b) To appoint Officer and servants at such remuneration (if any) as they think fit.
  - (c) To receive grants, donations and subscription.
  - (d) To make such Rules and regulations from time to time for the management and conduct of the affairs of the Trust it properties and assets.
- 9. The Trustees/Board with also have the follwoing powers:-
  - (a) To apply the whole or part of the income or accumulation thereof or whole or part of the corpus of the trust properties for one or more of the objects of the Trust as the Trustees may from time to time determine.
  - (b) To help, contribute, promote take over of amalgamate with any other society, Trust, Body or institution whether incorporated or not for the objects similar to those of the Trust herein.
  - (c) To invest and keep invested the trust properties either in the purchase or mortgage of immoveable properties or in shares, depentures or other securities or any business undertaking and


